Drilled 12 1/4" hole to 322' on 9/23/06, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 312'. Cemented w/200 sx (42 bbls) Tail Class "G" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 19 bbls of cement to surface. Test casing to 750 psi.

Drilled 8 3/4" hole to 4,035' on 10/1/06, set 91 jts of 7", J-55 LT&C, 23# casing at 4,022'. Cemented lead w/550 sx (142 bbls) 50/50 "G" POZ cement w/2% Gel, 2/10% Versaset, .10% FDPC766 and tail w/75 sx (19 bbls) 50/50 "G" POZ (tail) cement w/2% Gel, 2/10% Versaset, .10% FDPC766. No cement to surface, top of cement is at 312'. Tested casing to 2,000 psi.
