XTO Energy, Inc. requests approval for an exception to NMOC Rule 303-C to permit DHC of production from the Basin Dakota & Blanco Mesaverde in the State Gas Com BR #1E. XTO Energy, Inc. proposes to downhole commingling these pools upon completion of this well.

Allocations are based upon a Monthly Averages ~~9-section~~ and are calculated as follows:

Basin Dakota	Gas	17%	Oil	97%	Wtr	53%
Blanco Mesaverde	Gas	83%	Oil	3%	Wtr	47%

Both pools are included in the New Mexico Oil Conservation Division pre-approved pool combinations for downhole commingling in the San Juan Basin. Working Interest, net royalty interest & overriding royalty interest owners have been notified by certified, return receipt mail on October 23, 2006. The NMOC has been notified of our intent by submission of a C-103. Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights.
