It is intended to add the Menefee as follows:

1. MIRU. TOH with tubing.
2. Set CIBP @ 4750'. Pressure test casing to 3000 psi.
3. Run GR-CBL-CCL from CIBP to surface or 250' above cement top.
4. Run GR-N from CIBP to 2700'.
5. Selectively perforate the Menefee from 4360' - 4710'. Fracture treat with 60Q Foam.
6. Flow back well.
7. TIH, drill out CIBP and clean out to PBTD.
8. Land tubing @ 7034'. Return to production.
