06/02/03 MIRU. Run in tbg w/gauge ring. TIH. Gauge ring hung up @5937'. Drop wire cutter bar & POH slickline & cutter leaving 3830' slickline. RD slickline & fin spot rig equip. SDFN.

06/03/03 ND WH, NU BOP's. Pull up tbg to 60,000#, tbg hanger stuck. ND BOP's, remove plate & seals on top of Oct split tbg hanger, NU BOP's. Work tbg, still stuck at WH. Jack tbg, hanger free. SDFN.

06/04/03 ND BOP's P/U on Gallup tbg string to 70,000#, set hand slips under tbg hanger. Remove short side split tbg hgr, NU BOP's, work tbg & release string from j-slot tbg anchor. TOOH short side tbg string. L/D Perf subs, L/D btm jt w/J-latch Assy. TIH tbg, circ w/air on top of tbg anchor @ 5934'. TOOH tbg string. SDFN.

06/05/03 ND BOP's, Pull tbg hgr above WH, remove long string tbg hgr. NU BOP's, work tbg, stuck. RU Wireline. Fish for 3841' of slickline. Made 4 runs. RD Wireline. Work string tbg. No movement. SDFN.

06/06/03 RU Wireline, Run Overshot in tbg, retrieved slickline tools. Run free point, chem cutter above pkr. Cut tbg @ 5990', lost cutter assy. TOOH LD long string. TIH on 2 3/8" short string tbg, tag @ 5986' w/overshot & fell 5'. No Recovery. SDFN.

06/09/03 TIH on 2 3/8" tbg, work overshot over fish @ 5986'. TOOH. Recovered cutter assy @ 5990'. Change rams to 2 7/8", PU DC. TIH w/2 7/8" 6.7# N-80 Eue. Work stg of tbg, stop 30' above top of Gallup perfs @ 5603', Overshot @ 5573'. SDFN.

06/10/03 TIH w/tbg & OS fishing assy. Latch onto fish @ 5990'. Jar on fish w/70,000#. TOOH, recovered 1 piece tbg. MU washover shoe assy. TIH to 5000'. Unload hole w/air. TIH w/washover assy to top of fish, tie back tbg line. Wash over top of fish & top of pkr @

06/11/03 TIH w/2 7/8" tbg, tie back tbg line. Latch on tbg, jar on fish. No movement. TOOH, fish assy recovered. TIH w/ washover assy, tie back tbg line. circ w/air. Cut over stuck pkr, assy @ 5996'w/air to 6004'. Pkr dropped. Pull above perf's. SDFN.  
06/12/03 TOOH, L/D washover assy. TIH W/overshot, tie back tbg line, Catch fish. TOOH w/fish, Tie back to double line. Lay down tail pipe below pkr. Shut in. SDFN  
06/13/03 Blow Well down. TIH W/DC's & work tbg to top of Gallup perfs. Shut in. SDFN.  
06/14/03 Blow well down. PU 7" pkr @ 25.0' w/5500'tbg hung below pkr. ND BOP's & check for gas, OK. ND dual string tbg head, OK. Weld 4" stub onto 7" prod csg. NU new tbg head, NU BOP's, equalize pressure & rel pkr, Pull up & L/D pkr. TIH W/DC's & 2 7/8" tbg, tie back tbg line. Tag @ 6760', break circ w/air, circ hole. Clean, pump sweep, TOOH w/tbg.
