11/13/06. MIRUSU. TOH with tubing. Using RBP & packer combo, identified numerous casing leaks & formerly squeezed, perf leaks from 1985' - 3140'. TOH. Cut off 2-7/8" horizontal liner @ 3701' and TOH. Fish whipstock in vertical hole and TOH.

On 11/27/06, ran 4" IJ 9.5# J-55 liner and set on Model SLP liner hanger @ 3371'. Cement 4" liner with 236 cf (140 sx) Neat cement. Circulated 6 bbls cement to surface. Drill cement and hanger plug and clean out to 3790' in vertical hole. Landed 1-1/2" 2.75# J-55 IJ tubing @ 3764'. Tested horizontal PC on 12/6/06 on 1/4" choke @ 70 psi and 125 MCF/D. Ran pump & rods. Released rig 12/7/06.
