10-19-06 to 11-02-06; Mill window in 5 1/2" casing from 3684' MD to 3690' MD. Kick off and drill horizontal PC with 4 3/4" hole from 3684 MD to TD of 6756' MD. Land 2 7/8" 7.9# & 8.7# P-110 and N-80 tubing @ 6756' MD with ON/OFF tool @ 3668'. The 2 7/8" 7.9 & 8.7# tubing has a drilled and bull-plugged joint at the TD (6725-6756') with 28 open holes. There are 5 more joints that are drilled, tapped and plugged (with aluminum plugs, to be acid-dissolved upon completion) spaced as follows; 6252-6282', 5745-5776', 5248-5280', 4740-4772' and 4237-4267'. Each joint contains 28 holes. The drilling rig was released 11-04-06.
