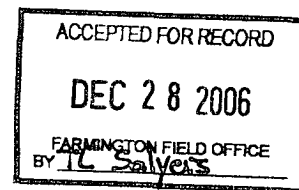

The above referenced well was spud on 12/12/06.

Drilled 12 1/4" hole to 285' on 12/12/06, set 6 jts of 9 5/8", H-40, ST&C, 32.3# casing at 277'. Cemented w/200 sx (42 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 750 psi.

Drilled 8 3/4" hole to 3,505' on 12/17/06, set 81 jts of 7", J-55 LT&C, 23# casing at 3,494'. Cemented lead w/575 sx (152 bbls) 50/50 POZ cement w/2% Gel, 0.2% Versaset, 0.1% Diacel LWL and tail w/75 sx (19 bbls) same slurry non-foamed. Circulated 15 bbls of cement to surface. Tested casing to 1,500 psi.
