Circ 3 bbls cement to surface. WOC. Install WH. RDMO. The casing PT will be conducted by the drilling rig and results will be shown on the next report.

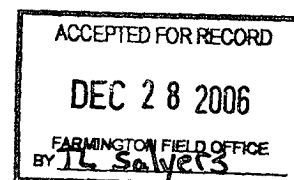
