On 11/27/06, tested all Tertiary perfs on 1/2" choke while swabbing for 45 psi and 375 MCF/D. Decided that no SQ work was warranted. Landed 2-3/8" 4.7# J-55 tbg @ 3263'. Ran pump & rods & started well pumping. Released rig on 11/28/06.
