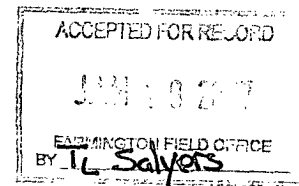

1/3/07 MIRU Aztec Well #184. Spud 12-1/4" hole @ 1930 hrs 1/4/07. Drilled to 338'. Circ. Hole. RIH w/8 jts 8-5/8", 24#, J-55 casing & set @ 338'. RU to cement. Pumped 5 bbls FW, 15 bbls mud flush & 10 bbls FW. Pumped 358 sx (411 cf-73 bbls) Class G cement w/2% CaCl2, 1/4#/sx Celloflake. Dropped plug and displaced w/21 bbls FW. Good circ throughout job, but not cement to surface. 1/5/07 Received verbal approval from Troy Salyer to top off cement using PVC pipe. 1/6/07 RIH w/2" Pipe & tagged top of cement @ 25'. Pumped 5 bbls spacer ahead of 175 sx (196 cf - 35 bbls) Class G cement and circulated to surface. TOH w/pipe. WOC. RD cementers. NU BOP. PT - OK. 1/7/07 PT casing to 600#/30 min. Good test.
