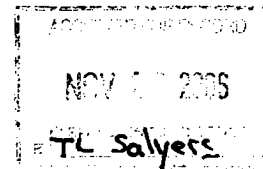

Drill to TD @ 940' on 10-25-06. Run 5 1/2" 15.5# J-55 csg in 7" hole. Land @ 932', float collar @ 890'. Cement w/45 sx Type 5 cement w/2% Lodense w/3# PhenoSeal & 1/4# celloflake/sx. Tail w/50 sx Type 5 cement w/3# PhenoSeal & 1/4# celloflake/sx (160 cu ft total slurry). Displace w/21 bbls water. Circ 6 bbls cement. Pressure test will be reported on completion sundry.
