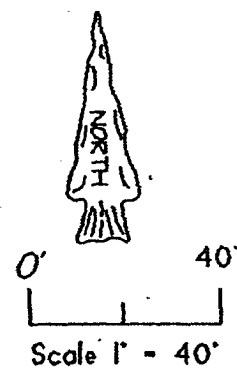

well pad and section

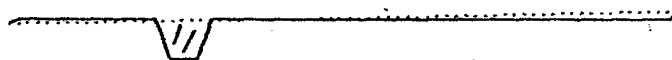
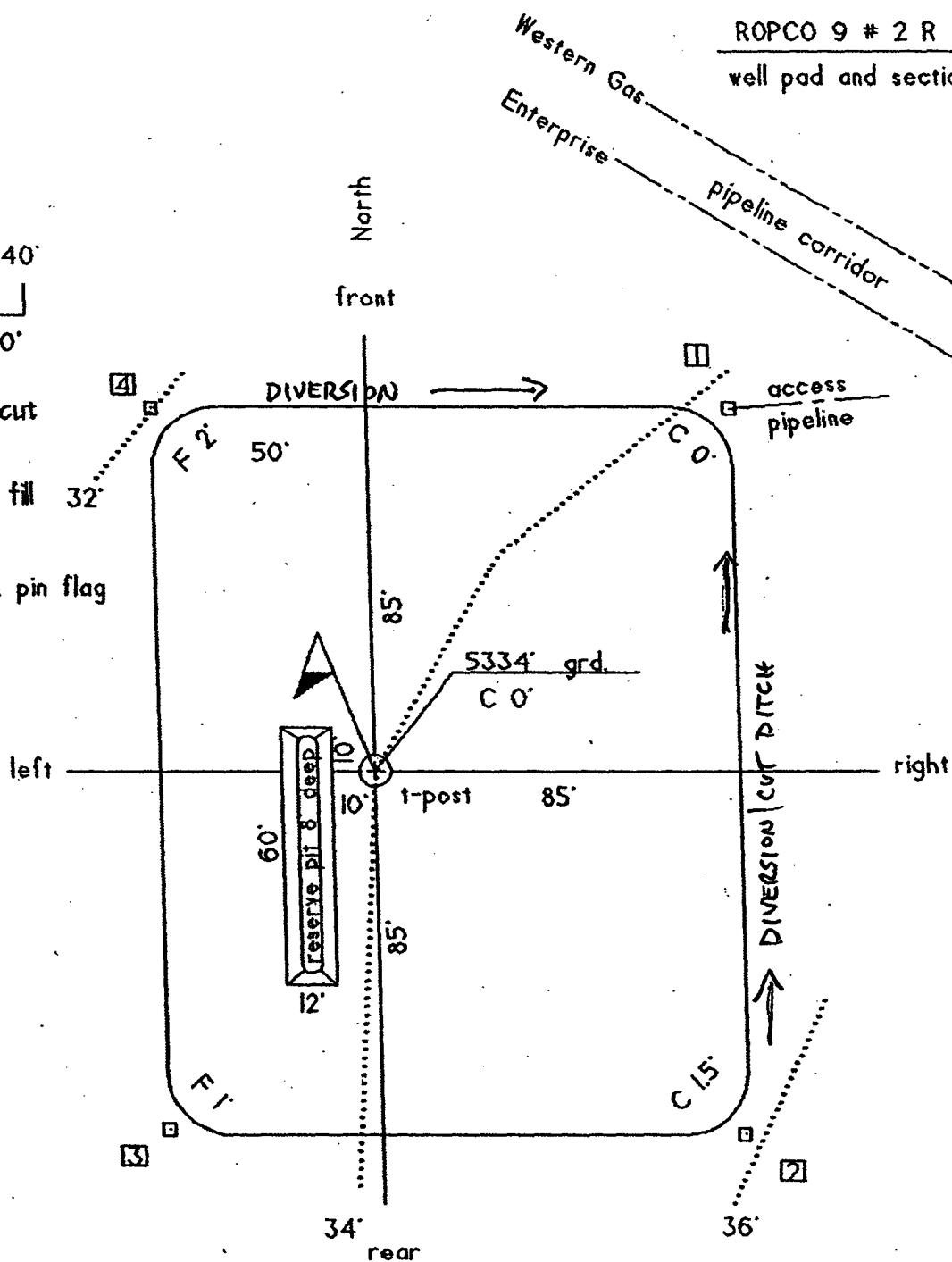
