

Cmt'd w/150 sx Type III cmt w/3% CaCl₂ & 1/4 pps Celloflakes (14.5 ppg & 1.42 cuft/sx). Displaced w/12.1 bbls; no cmt to surf. Could feel cement @ 26' w/plumbob. Ordered 50 more sx & 1" pipe. Cmt fell to 46' while waiting. Ran 1" to 45' and cmt top job w/20 sx; 5 bbls circ to surf. Finished job @ 4:30 p.m. Witnessed by Brice Hammond w/Jicarilla Oil & Gas. PT csg on 1/7/07 to 250 psig low f/10 min & 1000 high f/30 min. Tstd OK. Witnessed by Brice Hammond w/Jicarilla Oil & Gas.

Reached driller's TD of 2410' in 7-7/8 hole @ 7:30 p.m., 1/16/07.

Ran 5-1/2", 15.5#, J-55, LT&C csg to 2408' KB. Cmt'd w/200 sx Prem Lite cmt w/2% CaCl₂, 1/4 pps Celloflakes, 0.2% Dispersant, 0.5% FL-52 & 2% Phenoseal (12.5 ppg & 2.6 cuft/sx) f/b 150 sx Type III cmt w/1/4 pps Celloflakes, 0.3% Dispersant, 0.2% FL-52 & 2% Phenoseal (14.6 ppg & 1.41 cuft/sx). Circ 6 bbls cmt to surf.
