Drilled 7-7/8" hole to 1670' TD on 12/3/2006. Set 5-1/2", 15.5#, J-55 casing @ 1628' & cmt'd w/124 sx Prem Lite cmt w/2% CaCl2, 0.2% CD-32, 1/4 pps Celloflakes 0.5% FL-52 & 2 pps Phenoseal (12.5 ppg & 2 cuft/sx) f/b 100 sx Type III cmt w/2% CaCl2, 0.2% CD-32, 1/4 pps Celloflakes & 0.2% FL-52 (14.2 ppg & 1.48 cuft/sx). Circ 10 bbls cmt to surf.

PT 5-1/2" casing to 1500 psig for 30 min w/chart. Incr'd press to 2850 psig for 5 min. Tstd OK.
