

Set 7", 20#, J-55 intermed csg @ 1682' & cmt w/95 sx Prem Lite cmt w/1/2 pps Celloflakes, 0.5% disp, 2% Phenoseal & 2% KCl2 (12.5 ppg & 2.01 cuft/sx) f/b 100 sx Type III cmt w/1/4 pps Celloflakes, 0.2% disp & 2% Phenoseal. Circ 5 bbls cmt to pit. PT 7" csg w/BJ. Tstd OK.

Drilled 6-1/4" hole to 3170' TD on 12/13/06. Set 4-1/2", 10.5#, J-55 production csg @ 3162' & cmtd w/50 sx Type III cmt w/3% CaCl2 (15.2 ppg & 1.28 cuft/sx). Good circ. Bump plug OK.
