Reached driller's TD of 1735' on 12/17/2006. Drilled 7-7/8" hole and ran 39 jts 5-1/2", 15.5#, J-55 casing & set @ 1735' w/124 sx Prem Lite cmt & 100 sx Type III cmt. Circ 5 bbls cmt to surf.

Production casing will be PT at completion.
