Drilled 7-7/8" hole to 1740' TD on 12/10/2006. Set 5-1/2", 15.5#, J-55 csg @ 1730' & cmt'd w/124 sx Prem Lite cmt w/2% CaCl2, 1/4 pps Celloflakes, 0.2% cmt disp, 0.5% FL-52 & 2% Phenoseal (12.5 ppg & 2 cuft/sx) f/b 100 sx Type III cmt w/1/4 pps Celloflakes, 0.3% cmt disp, 0.2% FL-52 & 2% Phenoseal (14.2 ppg & 1.48 cuft/sx). Circ 7 bbls cmt to surf.

PT prod csg to 1500 psig for 30 min w/chart. Incr'd press to 3850 psig for 5 min. Tstd OK.
