Due to high line pressure and low wellhead psi, a compressor must be installed on the above mentioned well. The following measures have been taken to limit sound from the compressor:

- 1) Installed insulated sound wall w/muffler
- 2) Monitor noise for compliance

The compressor is a Caterpillar 3306, 95 hp circ recip 3-stage. The nearest house is 1.5 mile east of location.
