Drill to TD @ 1750' on 12/2/06. Run 5 1/2" 15.5# J-55 csg in 7" hole. Land csg @ 1736', float collar @ 1696'. Cement w/120 sx Type 5 cement w/2% Lodense, 2# PhenoSeal & 1/4# celloflake. Tail w/50 sx Type 5 cement w/2# PhenoSeal & 1/4# celloflake/sx (313 cu ft total slurry). Displace w/40 bbls water. Circulate 10 bbls cement. Pressure test will be reported on completion sundry.
