Deepening started 10/03/2006. Completed 10/20/2006. Drilled 100' into the Pictured Cliff formation to allow for a sump from which to pump water. We used a mudlogger during drilling to monitor the Pictured Cliff for signs of gas, there were none.

7" casing is unchanged, and set @ 2925'. Set new 5 1/2" 15.50# liner, top of liner @ 2856', bottom of liner landed @ 3407'. Liner was pre-drilled 2 SPF.

2 3/8" tubing run and landed @ 3336'. 3/4" rod string run.
