Deepening started 8/31/2006. Completed 9/16/2006. Drilled 100' into the Pictured Cliff formation to allow for a sump from which to pump water. We used a mudlogger during drilling to monitor the Pictured Cliff for signs of gas, there were none.

7" casing is unchanged, and set @ 2941'. Set new 5 1/2" 15.50# liner, top of liner @ 2887', bottom of liner landed @ 3411'. Liner was pre-drilled 2 SPF.

2 3/8" tubing run and landed @ 3358'. 3/4" rod string run.

Returned well to production 9/20/2006
