Drilled 7-7/8" hole to 1686' TD on 11/21/06. Set 5-1/2", 15.5#, J-55 csg @ 1684' & cmtd w/112 sx Prem Lite cmt w/2% CaCl2, 0.2% CD-32, 1/4 pps Celloflakes, 0.5% FL-52 & 2% Phenoseal (12.5 ppg & 2.01 cuft/sx) f/b 100 sx Type III cmt w/0.3% CD-32, 1/4 pps Celloflakes, 0.2% FL-52 & 2% Phenoseal (14.2 ppg & 1.48 cuft/sx). Circ 7 bbls cmt to surf.

Pressure tested 5-1/2" casing to 1500 psig for 30 min. Incr'd pressure to 2850 psig for 5 min w/chart. Tstd OK.
