TOH RIH w/11 jnts 4 1/2", J-55, 11.6#, LT&C csg on bottom, followed with 145 jnts 4 1/2", J-55, 10.5#, ST&C csg, and 34 jnts 4 1/2", J-55, 11.6#, LT&C csg on top. (set @ 8124'). RU to cement. Preflush w/10 bbl vis gel, 10 bbl wtr, 10 bbl vis gel. Pump 482 sx (674 cu ft - 119 bbl) Class G-POZ 50/05 cement w/ 0.25 pps D167, 0.15% D065, 0.10% D800, 0.10% D046, 3.5 pps phenoseal. Drop plug and displace w/84 bbl wtr. WOC RDMO 01/29/07.
