13. Describe Proposed or Completed Operations

Golden Oil abandoned the Dakota perforation and tested the 4.5" casing in this well per the following:

12/14/06: MOL and RU. Pull rods, determined a packer was at 6218'. Work packer free and TOH with 2.375" tubing. Ran casing scraper to 6930'. Replaced bad tubing. Set wireline CIBP at 7120' to shut off the Dakota perforations. Set packer at 5711' and pressure tested the casing annuls to 800#, held OK. TOH with packer. Land 220 joints 2.375" tubing at 7030' KB, with 1 joint tail pipe, 4' perfed sub and then SN at 6993' KB. Ran 2" X 1-1/4" x 16' RHAC pump and 186 -3/4" rods and 93 - 7/8" rods; spaced out and hung on head. Pressure test tubing to 500#, held OK. RD and MOL on 1/03/07.
