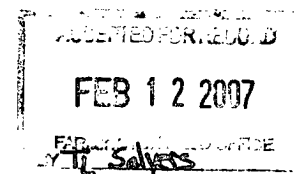

Cement 2nd stage with 400 sks Type G, 6% gel, 2% CaCl<sub>2</sub>, 10#/sk gilsonite, 1/4#/sk flocele (784 cu.ft.). Plug down @ 6:26 pm on 01/30/07. Circulate 20 bbls cement to surface. RD Halliburton. Release rig. Will test production casing during completion.
