

On 12/8/06, set 5-1/2", 15.5#, J-55 csg @ 6868' KB & cmt'd 1st stage w/310 sx Prem Lite cmt w/0.2% CD-32, 1/4 pps Celloflakes, 0.5% FL-52, 2 pps Phenoseal & 2% KCl₂ (12.5 ppg & 2.01 cuft/sx) f/b 150 sx Type III cmt w/0.3% CD-32, 1/4 pps Celloflakes, 0.2% FL-52 & 2 pps Phenoseal (14.2 ppg & 1.48 cuft/sx). Circ 35 bbls cmt to surf. Cmt'd 2nd stage w/580 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflakes, 2 pps Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 95 bbls cmt to surf. Rlsd drlg rig.

PT prod csg 1/17/07 to 2500 psig w/8 bbls 2% KCl wtr for 30 min w/chart. Incr'd press to 4000 psig for 5 min. Tstd OK.
