Cement with 100 sks Class B, 2% CaCl2, 1/4#/sk floccle (118 cu.ft.). Plug down @ 7:30 pm on 02/16/07. Circulate 5 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 750 psi - ok.
