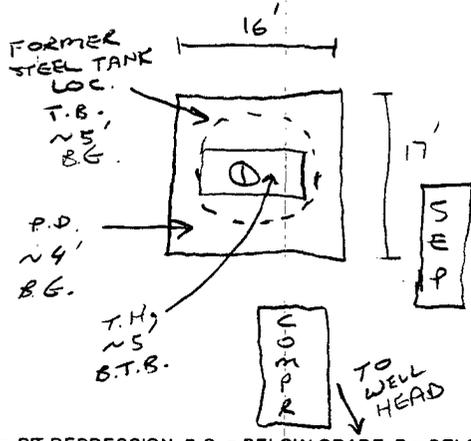

SKETCH/SAMPLE LOCATIONS



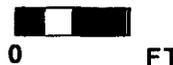

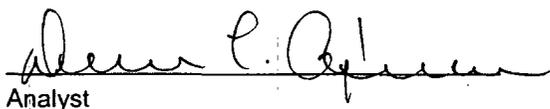

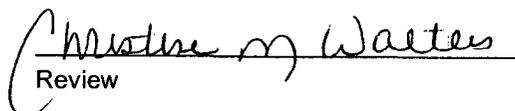
