Cemented 2nd stage lead w/600 sx (157 bbls) 50/50 POZ cement w/3% Gel, 0.6% Halad-9, 0.1% CFR-3, 5#/sx Gilsonite, 1/4#/sx Flocele, tail w/80 sx (11 bbls) Class "G" cement w/0.4% Halad 344. Circulated 40 bbls of cement to surface. Tested casing to 1,500 psi, held ok.
