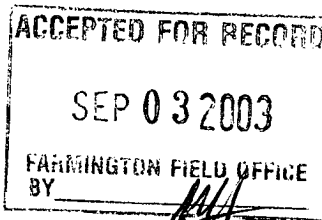

08/20/03 MIRU. ND WH, NU BOP's. Pull & LD tbg hgr, Tag PBTD @ 2020', No fill. TOOH. L/D 55 Jts tbg. Change over to 2 3/8" tbg. TIH w/2 3/8" 4.70#, J-55, EUE tbg. Stop at top of perfs. SI. SDFN.

08/21/03 Blow well down. TIH w/tbg, tag PBTD, No fill, Circ w/air. Pump 5 BBL 2% KCL water ahead, follow w/500 Gal 15% HCL Acid. Displace out end tbg w/7.3 BBL 2% water. Pull 7 stands tbg out & Shut well in. Let acid work. TIH w/tbg. Tag PBTD @ 2020'. Circ w/air. Unload water & cir clean. Pull up & let set 1 hr. TIH, tag PBTD @ 2020'. Circ clean. Land tbg on tbg hanger w end of tbg at 1871'. 60 Jts 2 3/8", J-55, 4.7#, EUE 8rd tbg run w/exp check on btm. ND BOP's, NU WH. Shut well in, RD.
