Drilled 7-7/8" hole to 7068' KB (TD) on 5/11/06. Set 5-1/2" 15.5#, J-55, LT&C csg @ 7049' KB on 5/12/07. Cmtd 1st stage w/336 sx Class G cmt w/2% CaCl2, 0.2% CD-32, 1/4 pps Celloflakes, 0.5% FL-52 & 2% Phenoseal (12.5 ppg & 2.01 cuft/sx) f/b 153 sx Class B cmt w/0.3% CD-32, 1/4 pps Celloflakes, 0.2% FL-52 & 2% Phenoseal (14.2 ppg & 1.52 cuft/sx). Circ 60 bbls cmt to surf. Cmtd 2nd stage on 5/13/06 w/460 sx Class G cmt w/8% Bentonite, 1/4 pps Celloflakes & 2% Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type B neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 40 bbls cmt to surf. RDMO.

Production casing will be tested upon completion.
