Circ 35 bbls good cmt to surf. Cmt'd 2nd stage w/375 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflakes & 2% Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt. Circ 16 bbls good cmt to surf.
