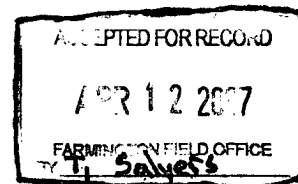

Cement with 200 sks Class G, 2% CaCl2, 5#/sk gilsonite, 1/8#/sk flocele (236 cu.ft.). Circulate 18 bbls cement to surface. Plug down @ 1:30 pm on 03/31/07. WOC. RD Halliburton. NU BOP. Test casing & BOP to 750 psi - ok.
