Cement with 150 sks 65/35 Class B poz, 2% CaCl2, 1/4#/sk floccale (177 cu.ft.). Plug down @ 4:45 pm on 04/11/07. Circulate 18 bbls cement to surface WOC. RD Halliburton. Surface casing test will be conducted prior to drilling out from under the surface. BLM will be notified to witness test.
