On 4/17/07, ran 3 joints of new 8-5/8", 23# L/S STC surface casing set at 138' KB (hole size is 12-1/4"). Cemented casing with 120 sacks Type G cement with 2% CaCl₂ and 1/4# bbl superfine. (Yield = 1.18 ft³/sk and wt = 15.6 lb/gal). Displace with 7.5 BBls of water. Plug down at 10:00AM. Good returns throughout job. Returned approximately 10 BBls cement to pit.

Pressure test on casing 600 psig. 12-1/4" hole TD at 145' reached on 4/16/07.
