

4/22/07 Drilled 12/14" hole to 226', ran 9 5/8", 36# J-55 STC Casing, landed @ 216' KB (KB=13.0) 4/23/07 Cemented with 180 sks, 15.2#, Type III Cement plus 3% CaCL, plus 0.25 lb/sk Celloflake, yield 1.28 230.4 cu. ft. We used 3 centralizers on the bottom 3 joints. Circulated 20 bbls cement to surface. Wait on cement 8 hours.

Tested BOPs 250# low and 2000# high for 5 minutes each. Tested 9 5/8" casing to 600# for 30 minutes, held O.K.

Tagged cement @ 185' in 9 5/8" casing.
