Cemented 1st stage lead w/300 sx (79 bbls) 50/50 "G" POZ w/3% Gel, 9% Halad-9, .1% HR-5, >2% CRF-3, 5 #/sx Gilsonite 1/8 #/sx Polyflake, top of cement for 1st stage is 5,693'. Inflate pakcer and open DV tool.
