2.TOOH W/ 2 3/8" TUBING

3.TIH W/ 4 1/2" BIT & SCRAPERTO PBTD

4.TIH W/ A RBP & RP & SET RBP @ 2745'. DUMP 5 SX OF SAND ON TOP OF RPB. SET PACKER @ +/- 100 FT ABOVE, LOAD BACKSIDE W/ 500 PSI, EST. INJECTION, AND PERFORM HESITATION CEMENT SQUEEZE, ALLOW CEMENT TO SETUP @ LEAST 24 HRS.

5.TIH W/ BIT & SCRAPER & DRILL OUT CEMENT, PRESSURE TEST TO 2000 PSI FOR 15 MINUTES.

6.TOOH & LD BIT & SCRAPER, TIH W/ RETRIEVE HEAD FOR RBP AND WASH SAND OFF OF RBP AND RETRIEVE.

7.CLEAN OUT W/ AIR TO PBTD. TIH W/ TUBING AND BHA PER PROD. FOREMAN'S SPECS. NO BOR. NUMH. TIH W/ RODS AND PUMP.

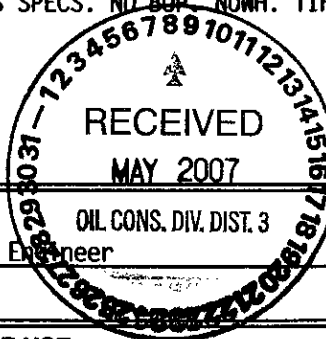
