
Prior to commingling operations, the Blanco-Mesaverde was producing @ a stabilized rate of about 160 MCFPD and 0 BOPD. The WC basin Mancos was added in March of 2007, and the well has reached a stabilized rate of 290 MCFPD and 0 BOPD. The following allocation is recommended:
