

Objective: Plug and abandon

Procedure:

Before the rig arrives, dig, line, and fence, a 12' X 12' workover pit.

1. Move on location and rig up a completion rig. Hold safety meeting.
2. Nipple up a 2-3/8" relief line to the pit. Blow well down and kill with water if necessary.
3. Nipple down the wellhead and nipple up a BOP. Tally out of the hole with 34 jts. of 2-3/8" tubing.
4. Pick up a 5-1/2" cement retainer on 2-3/8" tubing and TIH. Set the cement retainer at 845' (~~50' above the~~ Fruitland top). Pump 25 sx (30 cu.ft) of Type 5 cement below the retainer. Sting out of the retainer and leave ~~5-sx~~ of cement on top of the retainer. POH to 200'. ^{820'} to 770'.
5. Load the hole with water and pressure test the casing to 500 psi. Spot a surface plug from 200' to surface with 25 sx (30 cu.ft.) of Type 5 neat cement.
6. TOH. Nipple down the BOP and wellhead. Top off the surface plug with neat cement as necessary.
7. Cut off wellhead and install dryhole marker. Reclaim location as per BLM specifications.
