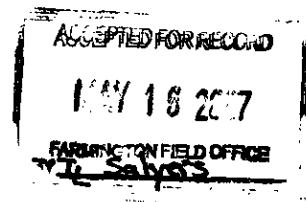
On 4/6/07, ran 3 joints of new 8-5/8", 23 # L/S STC surface casing set at 142' KB. (Hole size is 12-1/4"). Cemented casing with 120 sacks Type G cement with 2% CaCl<sub>2</sub> and 1/4#/bbl superfine. (Yield = 1.18 ft<sup>3</sup>/sk and wt = 15.6 lb/gal. Displace with 7.5 BBls of water. Plug down at 10:30 AM. Good returns throughout job. Returned approximately 5 BBls of cement to pit.

Pressure test on casing 600 psi. 12-1/4" hole TD at 145'.
