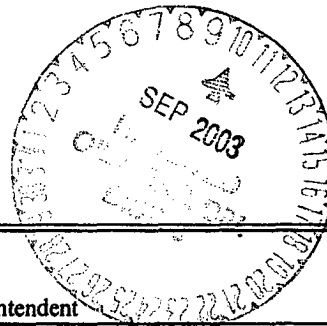

Drilled 12 1/4" hole and ran 9 5/8", J-55 36# ST&C casing and landed @ 267' KB. KB = 13' 0"

Ran centralizers on the bottom 3 joints including shoe joint. Cemented with 185 sks 15.8# Class G Cement with 2% CaCl₂, .25 lb/sk D29 Cellophane, yield 1.16. Circulated 10 bbls cement to surface. WOC cement 12 hours.

8/21/03 - Pressure tested casing to 750 psi for 30 minutes. Held O.K. Tagged cement @ 250'.
