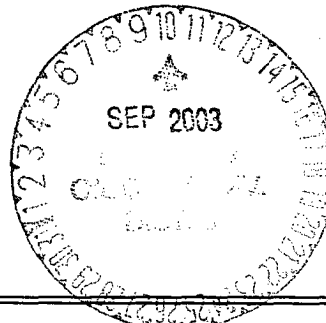

Bumped plug @ 0643 hrs 9/2/03. Circ. 20 bbls good cement to surface. WOC. NU WH & BOP. PT BOP - OK. PT casing to 250 psi low and 1000 psi for 30 minutes. Good test.
