Tail - 100 sx (127 cf - 22.6 bbl slurry) 50/50/G/POZ w/2% Bentonite, 2% CaCl2, 5#/sx Gilsonite, 0.25#/sx Celloflake & 0.2% Antifoam agent. Released wiper plug & displaced w/10 bbls FW & 113.7 bbls polymerized drill water. Bumped plug w/2000 psi @ 2042 hrs 8/24/03. Circ. 80 sx Cement to suface. RD Schlumberger. ND BOP.
