Tail - 100 sx (127 cf - 22.5 bbl slurry) 50/50 Class G POZ w/2% gel, 5#/sx Gilsonite, 2% CaCl2, 0.25#/sx Cellophane, & 0.2% Antifoam. Released wiper plug and displaced w/20 bbls FW & 1000 bbls drill water. Bumped plug w/1200 psi @ 0230 hrs. Circ. 40 bbls good cement to surface. RD Schlumberger.
