Drilled 6 3/4" hole to 2400' and ran 4 1/2", J-55, 10.5# STC casing, landed casing @2379.32' KB. KB = 5'0"

Ran centralizers on the bottom 3 joints including shoe joint, and ran 2 turbulizers below the Ojo and the 1st joint into the Ojo. Pumped 14 sks 10.5# scavenger w/ dye then cement: Lead with 247 sks 12.5# Class B Cement, with 2% Sodium Metasilicate, .25#/sk Cello Flake, 3 pps Gilsonite, 2pps phenoseal, yield 2.09. Tail with 60 sks 14.5# Class B cement with 4% gel, 2% CaCl2, .25#/sk Cello Flake, yield 1.55. Displace with 37 blls of H2O. Bump plug @ 1200#, plug held. Had circulation throughout job, no cement returns to surface. Will run CBL & GSL at a later date.
