Cement with 125 sks Class B poz, 2% CaCl2, 1/4#/sk flocele (148 cu.ft.). Circulate 10 bbls cement to surface. Plug down @ 9:30 am on 04/25/07. WOC. RD Halliburton. RDMO. Surface casing test will be conducted prior to drilling from out under the surface. BLM will be notified to witness test.
