04/20-21/07 - Flow back frac on 1/8" choke for 8 hrs., then 1/4" choke over weekend.

04/30/07 - TIH with 2.375" tubing, set @ 5971'. ND BOP. NUWH. Return to production. Flow test Menefee for short period of time to determine Menefee potential. Will return to well and land tubing @ 6201'.
