Drilled 12 1/4" hole to 315' on 4/29/07, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 310'. Cemented w/250 sx (52 bbls) "G" cement w/2% CaCl and 1/8#/sx Polyflake. Circulated 20 bbls of cement to surface. Test casing to 1,000 psi.
