Broke down new interval w/300 gal 7.5% HCL acid. Swab tested 0 MCF & 0 fluid. On 5/15/07, tested total well for 6 hours on 1/4" choke while swabbing for 39 psi for 80 MCF/D & 60 BWPD. TOH & lay down all 2-3/8" tbg. Released rig on 5/16/07. We plan to P&A or plugback & transfer ownership to the Jicarilla Tribe.
